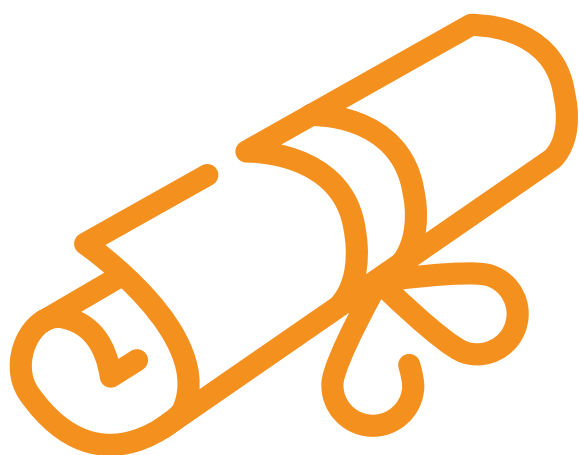


CORGI QUALITY ACCREDITATION SCHEME

Who can become CORGI Accredited?

CORGI Quality Accreditation Scheme is available to residential social housing providers, private landlords and contractors working with them or any organisation wishing to strengthen its business through accreditation.

What does the CQA scheme do?

- Fulfills regulatory and best practice standards
- Reduces the risk of an HCA Serious Detriment Notice
- Identifies and closes down risk through ongoing, comprehensive audits
- Delivers a framework to maintain robust standards in spite of organisational changes, welfare reforms and economic challenges
- Delivers cost and efficiency savings to your organisation
- Gives national recognition in achieving Quality Management Systems

The scheme also provides:

- Fulfillment of tender requirements
- Alignment with ISO9001, ISO17021 and IAF mandatory documents

The CORGI Quality Accreditation Scheme has been designed to assess the quality of management systems and processes in place for achieving safe gas work. The accreditation is valid for three years with annual surveillance visits. To achieve accreditation, high standards must be achieved in the following areas:

- ✓ **Company ethos & policies** – showing an organisation's commitment to gas safety
- ✓ **Work scope** – general work activities & records
- ✓ **Training & qualifications** – mechanisms used for control of operatives' qualifications
- ✓ **Work allocation** – how work allocation is controlled
- ✓ **Supervision & quality control** – arrangements for when, how and by whom
- ✓ **Procedures** – specific procedures including for work undertaken (eg engagement of contractors), gas emergencies, unsafe situations, gaining access, voids, mutual exchange
- ✓ **Work documentation** – the company's policy for documentation
- ✓ **Technical support** – how and when technical support will be provided to engineers
- ✓ **Gas complaints procedures** – processes in place for learning from gas complaints and dealing effectively with gas work deficiencies
